PUPPY SALES AGREEMENT

This agreement is made between WHISPERING PINES FARM, hereafter referred to as “SELLER” and _____, hereafter referred to as “BUYER.”

A holding fee in the amount of \$ _____ has been paid towards the purchase of one LABRADOR RETRIEVER PUPPY (male/female; black/chocolate/yellow) from litter born on _____. The balance of \$ _____ will be paid upon pick-up or before shipment of puppy to BUYER. BUYER is given choice of puppy in the order the deposit is received. If BUYER cannot make a choice by the 35th day after puppy is born, SELLER will choose puppy for BUYER.

BUYER agrees to and understands the following conditions:

§ The puppy will not be sold, leased or given to any pet shop or research establishment.

§ The puppy shall not be sold, given or donated to any person without SELLER’s prior knowledge and consent.

§ The puppy will be kept in appropriate conditions for its health and welfare and will be fed a suitable diet for its age and condition. Nutrition is of utmost importance for the health of your dog. We require that you feed your puppy [LIFE’s ABUNDANCE](#) food for at least the first 26 months in order to give you our Health Guarantee (see below).

§ Puppy will not be allowed to roam free, must never be left unattended on a chain or rope, or ride loose in the back of a pickup truck.

§ Puppy will receive regular booster vaccinations from a veterinarian, and will receive all necessary veterinary care to maintain its good health.

§ If BUYER registers puppy with the American Kennel Club (AKC), BUYER agrees to include the kennel name “Whispering Pines” in the registered name.

§ In the event BUYER cannot keep the puppy/dog for whatever reason, BUYER agrees to return dog to SELLER at no expense to SELLER.

§ BUYER understands that if there is a failure to keep any part of this contract, or if the puppy is neglected, maltreated, or is failing to receive adequate medical care, BUYER will surrender said puppy to SELLER unconditionally and without financial restitution or compensation.

SELLER transfers all rights, privileges and the responsibilities associated with the ownership of the LABRADOR RETRIEVER as of the date given below. All American Kennel Club (AKC) registration papers are included in the purchase price unless otherwise noted in writing.

SELLER guarantees to BUYER the dog specified above is in good health, has been inoculated and wormed. SELLER guarantees to BUYER that the puppy will hunt with proper training.

(Initial)

SELLER also guarantees the pup to be free of all genetic diseases of hips, eyes, and elbows for 26 months from the puppy's date of birth. In the event of the emergence of any of the above conditions, diagnosed by a licensed veterinarian chosen by the BUYER on or before 26 months from birth, the BUYER shall immediately notify the SELLER of such condition and the diagnosis. SELLER shall replace the puppy to the original BUYER subject to the following conditions.

HEALTH GUARANTEE CONDITIONS:

1. SELLER, at his option, may require BUYER to forward all medical records, x-rays and other information relied upon for the diagnosis to SELLER for a secondary opinion from a licensed veterinarian. SELLER also has the option, at his expense, to require that a licensed veterinarian examine the dog. Expenses for the initial diagnosis and shipping of all records, ex-rays, and other information relied upon for the diagnosis is the responsibility of the BUYER. SELLER shall return all medical records to BUYER at SELLERS expense. Expenses for transportation of the dog to and from second examination are the responsibility of the SELLER.
2. In the event both veterinarians arrive at the same diagnosis, the SELLER will replace the dog. All shipping expenses are the responsibility of the BUYER.
3. In the event there are differing diagnoses, BUYER may request a third examination by a licensed veterinarian agreeable to SELLER. All expenses associated with this third examination and diagnosis shall be the responsibility of the BUYER. The diagnosis resulting from this third examination will be binding.
4. BUYER agrees to provide proof that the dog has been spayed/neutered prior to the replacement by SELLER.
5. BUYER agrees that no American Kennel Club registration will be given to any offspring of the dog whelped after date of initial diagnosis.

This contract applies to the original puppy BUYER only and is not transferable to a second party.
